## Contract for the arrangement of the 2<sup>nd</sup> Edition of the Floorball Champions Cup 2015 - 2017

	the Swedish Floorball Federation (Svenska Innebandyförbundet r.f.) Box 1047, 17121 Solna, SWEDEN					
	the Swiss Floorball Association (Schweizerischer Unihockey Verband) Ostermundigenstrasse 69, Postfach 621, CH-3000 Bern 22, SWITZERLAND (hereafter the NA's)					
§ 1.	The obove mentioned parties have agreed upon the need to continue to arrange and organise an yearly European Top Club competition called the Champions Cup in order to maintain a show case for International Floorball for the period of 2015 – 2017.					
§ 2.	The stakeholders of the Champions Cup are the Internation Floorball Federation, the Czech Floorball Union, the Finnish Floorball Federation and the Swedish Floorball Federation, with the Swiss Floorball Federation as a non-organising stakeholder.					
	The Champions Cup will be organised once a year during the period of 2015 – 2017 in October by Czech Republic (2015), Sweden (2016) and Finland (2017), hereafter mentioned as organiser.					
	The stakeholders are to separately negotiate and agree upon the conditions for how the Swiss Club teams can participate in the CC. The parties will separately discuss the organisation of the Champions Cup for 2018 and onwards.					
	The SUHV confirm by signing this agreement the participation of the Swiss Champions men and women in the Champions Cup for the contractual period 2015 – 2017. The SUHV are to pay 15.000 EUR/team/year for participation in the Champions Cup.					
	Each year the parties will evaluate the competition and all issues related to it in November, possibly additionally using an external company.					
§ 2.1	The CC shall be organised only in the vicinities of the commonly agreed EFT arrival cities, with broad enough spectator capacity and nerbay an international airport.					
§ 2.2	The Champions Cup will be organised in accordance with the IFF Regulation for the Organisation of the Champions Cup, edition 2015, approved by the IFF and the parties of this contract.					
§ 2.3.	The duties and responsibilities of the organizers are laid down in primary this contract and secondly in the IFF Organizers Regulations, IFF Event Handbook and the contract between IFF and the organizer.					
§ 2.4.	The cost allocation system as stated in the 'Regulations for Organisation of the Champions Cup' applies for all stakeholders, with exception of the Swiss association.

The three organising national associations have determined the financial requirements for participation of the Swiss Club teams in the CC. The Swiss association shall pay this special participation fee separately for each year.

The SUHV has by signing this agreement confirm their participation in the Champions Cup for the contractual period 2015 – 2017.

- § 3. The Champions Cup will be played as a six men's and women's team event, during three days, in accordance with the IFF regulation for the Champions Cup in a single venue, if possible.
- § 4. A separate contract for organising the Champions Cup shall be made between the IFF and the organizer in accordance to § 2.
- § 5. The parties concerned agreed to that changes to this contract can be made only in a joint meeting every year after the Champions Cup has been played.
- § 6. The parties concerned agree to keep the content of this agreement confidential with-in the Central Boards of their organisations.
- § 7. The Finnish and the Swedish associations committees to each pay a sum not exceeding EUR 25.000 to the Czech association, as compensation for a possible loss, if there for one or the other reason, after a decision November 2015, will not be organised a sixth or sevent edition of the Champions Cup after 2015.
- § 8. The stakeholders concerned agree to invest on a yearly level a sum of 5.000 EUR to develop the Champions Cup, with the possibility to employ a half-time FTE as the CC Product Manager starting from March 2015, in order to focus on the objectives to reach the financial targets of the CC.
- § 9. This contract may not be transferred by a party to a third party without the approval of all parties. This contract has been signed in five originals, one for each party.
- § 10. Any modifications to this contract must be made in writing and has to be agreed separately between all parties. In the event, that questions as to matters not mentioned in this agreement arise, they shall be negotiated in good faith between the parties concerned.
