Contract concerning the Establishment of a School Floorball Development Center in China under the aspics of IFF

Between:

International Floorball Federation, Alakiventie 2, 00850 Helsinki, Finland (hereafter IFF) as the first party,

and

Shanghai International Studies University (hereafter SISU) as the second party

Now the parties agree upon the following in connection with the establishment of a Student Floorball Development Center in China as a part of the International Floorball Federation's activities to develop Floorball in China:

- § 1. The parties has now agreed to enter into a cooperation, in order to speed up the development of Floorball in China.
- § 2. For the IFF the focus is to gain as many active and working member associations as possible and strives to have a membership association also in the Republic of China.
- §3. The SISU has as their primary target to promote the sport of Floorball in the Universities and HighSchools in the Shanghai region and also in other regions of China.
- §4. SISU understands the need of IFF to have a National Floorball Association in China and is willing to work in order to make this possible in the future. The primary target of SISU is to form a University Floorball Federation.
- §5. As a part of this process SISU is hereby authorised by IFF to establish the IFF Student Floorball Development Center in China (hereinafter referred to as IFF Development Center) mainly to popularise Floorball in schools in China (including primary schools, middle schools and universities) under the support of IFF and with the assistance of Federation of University Sports of Shanghai and Joint Secretariat of School Sports Federation.
- §6. The IFF Development Center is empowered to provide trainings, under the guidance of IFF, for Chinese Floorball teachers and referees, and organising a number of competitions for the students.
- §7. The IFF Development Center is also entitled to issue official certificates for a Level 1 Coach and Referee grades, printed with IFF logo.
- §8. IFF shall provide technical and educational support to the IFF Development Center, including designating professional coaches to China to give lectures, so as to promote the healthy development of Floorball in China. The IFF Development Center must produce a time table for all trainings organised by IFF at least six (6) months prior to the event, in order for IFF to be able to prepare the activities.

Signatures:

- §9. IFF will provide the IFF Development Center with guidance and assistance as to national school Floorball competitions, which the IFF Development Center will organise.
- §10. Once the agreement is signed, IFF Development Center is required to submit annual reports on its development plans and objectives to IFF. The IFF Development Center is to provide the IFF with a plan for the next year one month prior to the start of the year.
- §11. IFF Development Center shall collect and submit to IFF the materials on all Floorball activities and competitions in schools in China.
- §12. IFF comittes to support the IFF Development Center with an amount of Floorball material (sticks, balls and other materials) each year based on a joint agreement, starting when the IFF Development Center has started its activities.
- §14. The parties have a joint understanding that the IFF Development Center will try to organise an IFF Development Seminar in 2013 and are looking into the possibility to participate in either the FISU World University Championships or the Asia-Oceania Floorball Championships latest in 2014.
- §15. IFF will look for a way to affiliate the Students Sports organisation with the IFF, in order to full-fill the need of having at least 75 member associations by May 2015.
- \$16. The parties conserned agreed to keep the content of this agreement confidential with-in the Central Boards of both organisations.
- §17. The agreement is valid for a period of three years, starting from the 1st of January 2012 and ending the 31st of December 2014.
