

COOPERATION AGREEMENT**1. Parties:**

A4SP Technologies Ltd. (Business Identity Code 2054963-1), located in P.O. Box 541, Tekniikantie 21 A, 02151, Espoo (hereafter A4SP)

and

The International Floorball Federation , located in Alakiventie 2, 00920 Helsinki, Finland (hereafter IFF)

Jointly or separately Parties or Party.

2. Background:

Background of the Parties:

A4SP is a company, whose objective is to with its products develop proficiency in floorball and other sports in an entertaining and a useful way. The products are suitable for both amateurs and competitive players.

The International Floorball Federation, IFF is the head organisation of world floorball. IFF was founded by Sweden, Finland and Switzerland 1986. At this moment the IFF has 39 member associations. IFF is an ordinary member of GAISF and cooperates with both FISU and EMSA. IFF now stresses three different fields. These are, marketing, development and politics, the latter meaning in the field of sports.

Background for the cooperation:

Both of the Parties aim to increase the interest in floorball, to develop the sport and to increase floorball's competitiveness. By initiating the cooperation the Parties enhance reaching these goals.

3. Objectives:

The objective of the cooperation is to increase the interest in floorball as a sport and with the product of A4SP make training floorball more entertaining and goal-oriented.

As a part of the cooperation IFF has the possibility to inform about its needs for the development of the A4SP's product concept.

In addition, the aim is to collaborate in the promoting of the activities of IFF and the product concept of A4SP, for example in sport events, www-pages, publications etc.

4. Areas of collaboration:

Both Parties are committed to promote jointly IFF's objectives and A4SP's product concept.

The cooperation and promotion consists of:

Www-pages:

Both Parties promote the other Party as a partner on their www-pages. IFF recommends A4SP's product concept as a device for enhancing players' floorball skills. A4SP can launch Floorball 08 on IFF's websites and product information about A4SP's product will be added either straight to IFF's websites or through a link to A4SP's website.

Events:

The Parties cooperate in selected IFF's events to promote A4SP's product concept by either demo's or presentations. The possible events for cooperation are championships, IFF's development seminars and meetings.

The events will be selected from e.g.:

ISPO Sports and Style 2007, Germany
Men's U19 World Championship 2007, Switzerland
Men's World Championship 2008, Czech Republic
Women's U19 World Championship 2008, Poland
EuroFloorball Cup 2007/2008

For IFF's seminars, A4SP will provide IFF 20 pieces of A4SP's products and the needed software as soon as available and train IFF's selected members to use the product for training in jointly agreed seminars. The products delivered for IFF are for IFF's own use and for demonstration purposes.

A more detailed action plan will be regularly updated and agreed on between the Parties.

5. Other terms

This cooperation agreement is public and therefore A4SP has the right to use IFF's logo and mention IFF as a partner organisation.

All IPR-rights concerning the products and the product concept of A4SP belong to A4SP and therefore are not transferred along with this agreement.

Development work, in which risks on realization, implementation and schedule appear, is related to the R&D of A4SP. The realization of these kinds of risks do not entitle for compensations.

Both Parties defray their own expenses unless otherwise is separately agreed.

By this agreement, no monetary contribution is transferred between the Parties.

This agreement shall be governed solely by Finnish law and any disputes arising from it shall be finally settled in Helsinki by arbitration in accordance with the Arbitration Rules of the Finnish Central Chamber of Commerce. Finnish language shall be used in the procedure.

6. Confidentiality

IFF is obliged to keep secret all confidential information or information understandable as confidential that it gets from A4SP or during product development.

7. Validity of the agreement

This agreement enters into force when both Parties have signed it.

This agreement is valid until 31.12.2008 and is updated if needed. After 31.10.2008 the cooperation agreement is updated and re-signed between the Parties for the period commencing 1.1.2009.
