Report on present issues

1) Opening of the Meeting

Mr. Sani Mohd. Salim opened the AOFC GA and greeted all the participants welcome to the General Assembly in Singapore, hoping that everyone had enjoyed the ongoing APAC. Mr. Renato Orlando greeted the General Assembly in the name of the IFF President Mr. Tomas Eriksson and thanked the AOFC CB for the actions taken so far.

2) Approval of present Associations and the voting roll

Mr. Salim conducted the roll call and the following member associations were present; Australia, India, Japan, Korea, Malaysia and Singapore

3) Approval of the CB report

Mr. Salim gave a short report of what has been done during the last years. The AOFC office has been opened at the Valhalla Sports Hall, with the help of the Singapore Sports Council and Ms. Rossilawati Roslan has been employed as the secretary of the AOFC, since the start of 2007. Two lecturers from AOFC (Emily Koh and Lily Suriani Tan) have been sent by IFF and AOFC to conduct a coaching seminar in Beijing and Mr. Salim and Mr. Suresh and Ms. Roslan participated in an event for developing Floorball in Thailand in July. Also a qualification for the Women's WFC has been organised between Singapore and Japan.

4) Approval of the financial report and the auditors report

Mr. Salim explained that there have been some problems to open a bank account for the AOFC, which will be solved now after the present AOFC General Assembly.

5) Approval of the budget and working plan for the next two years

Mr. Salim presented a plan for the coming years, stressing on the need to develop the activities of the AOFC, by increasing the number of international competitions, building own coaching materials and promote Floorball in the region, finding new countries in this area. One task for the AOFC is to focus on the referee development, in order to have an Asian referee pair refereeing in an IFF World Championship in the future.

AOFC will establish two subcommittees. The committees are a Technical committee looking after the Development issues, like referees, coaching and other development issues. The second committee would concentrate on Marketing and Information.

Mr. Salim expressed that the AOFC office and the committees will come with their proposal for a budget for their respective areas to the AOFC CB.

6) Elections

AOFC President for two years

Mr. Sani Mohd. Salim was re-elected as the President of AOFC for 2008-2009.

Nine CB members for two years

Australia made a proposal to change the AOFC Statutes, so that non-citizens can be elected for the AOFC CB. The proposal was approved and the statutes changed. The elected CB.

Mr. Gill representing India asked why there were no Indian elected to the AOFC CB. Mr. Suresh explained that there had been no proposal given by the Indian Federation, in time and therefore it is not possible to elect any Indian to the AOFC CB. Mr. King pointed out that the AOFC looks forward to have an Indian nominee in 2009 and hoped that there could be representatives included from India in the committees.
